**Ching Ming Festival:** The President and Directors will attend the Ching Ming Festival worship service. In view of ongoing health & safety Covid concerns, members are not permitted to attend.

**Goon Yee Tong Club House:** Goon Yee Tong intends to have a clubhouse that can meet the needs for the members. In 2016, the Board of Directors started looking for a new clubhouse around Chinatown with the elevator facility. This original plan had been greatly affected due to the rising price of the property market at that time and subsequently the decrease in rental income due to the pandemic. Furthermore, the possibility for the distribution of LYT's property, i.e. No 50 & 52 Dixon Street may create some uncertainties of the usage rights of the No 50 Dixon Street. In view of GYT's No 54 Dixon Street currently being vacant and the need for the renovation inside the building, the Board of Directors have proposed the idea of adding the elevator and designing the top floor as a new clubhouse. The rental income is expected to increase due to the fact that the renovated shops will be more competitive in the market. The specific plan will be reported to members when GYT gathers more concrete details. It is hoped to have the strong support from members when this plan is confirmed.
